# What is the Australian Young Farmer Challenge?

# A showcase of young people in Australian agriculture, competing in diverse challenges of skill, technique, knowledge and safety.

The Australian Young Farmer Challenge (AYFC) is an engaging, entertaining and fast paced competition for young rural people (aged 18-35 years). The AYFC is a demonstration of the talent, skills, techniques and safe work methods that young farmers use every day.

It showcases the breadth of technical skills and knowledge required in farming today and the proactive involvement of young people in our industry.

Teams compete in a series of skills-based challenges related to farming with a strong emphasis on technique and safety. Competitors are asked to do their best to complete the challenges correctly against the clock, as well to focus on safety, and most importantly, enjoy the competition and provide entertainment to the audience.

# Fosters participation and engagement of youth from rural and regional communities in across the country.

The AYFC is inspired by the successful Young Farmer Contest held in New Zealand since 1969. Each year up to 400 young people from across NZ battle it out for the top spot right through from club level to the Grand Final.

The AYFC has become a cornerstone agricultural youth event in Australia. It is held across many states in Australia with a National AYFC Final competition held at a state show annually.

# Aims to ENGAGE, ENTERTAIN and EDUCATE local and a broader, urban based audience about food, fibre modern Australian agriculture.

The AYFC is a great way to engage young people from your community. It is an easy to run, low input and highly entertaining entertainment option for local regional and state events. The AYFC can showcase and educate audiences about agricultural principles, especially those important to your local community.

### This is a comprehensive information handbook, for you to run an AYFC.

Be creative, use local products and equipment, set challenges specific to your local farming area, test your young farmers and entertain your audience, build local enthusiasm and have fun.

# **AYFC Structure and Management**

The AYFC is an initiative of Agricultural Shows Australia (ASA) and the developing National Next Gen Committee.

Over 100 AYFC Competitions are run annually at agricultural shows across Australia. Competitors progress through a series of qualifying heats, run at local, regional and state agricultural shows and events, with each state final competition a qualifier for the National AYFC competition.

At the National AYFC, Competitors from across Australia come together and compete in front of bumper crowds from both rural and metropolitan backgrounds each year at a different State Show.

The competition structure agreed to by the Australian Young Farmer Challenge Working Group can be found below in Figure 1. Some states are still in a development phase and their structure will be updated once confirmed. Greyed items in Figure 1 indicate sections of the structure under development.

Figure 1: Australian Young Farmer Challenge Competition Structure agreed to by ASA National Next Gen AYFC Working Group - May 2020.



The National AYFC Competition is managed by the AYFC Working Group and is hosted by a different State Show annually. The winners of each State Final (or nominated representative for States with developing structure) will compete in the National AYFC Competition.

The State Finals are organised by the State Royal Show or other recognised State body and is hosted at the State Show. The winner of the State Final will be eligible to compete as the State representative at the National AYFC Competition.

More broadly, Regional heats may be run in conjunction with the State Show or at another Regional Show (i.e.: Zone Final). Regional heats winners are eligible to compete in the Regional Final, and the Regional Final winners will compete in the State Finals.

Local AYFC Competitions are organised by local Show and Committees and the winning teams qualify to compete in Regional Competition heats.







### **State AYFC Overview**

### **Australian Capital Territory AYFC Structure**

AYFC under development.

### **New South Wales AYFC Structure**

The RAS of NSW Youth Group run the NSW AYFC State Final at the Sydney Royal Easter Show each year.

AYFC Regional qualifying heats will be run by the RAS of NSW at the Sydney Royal Easter Show, prior to the State Final. The four top-qualifying teams will progress through to the State Final held at the Sydney Royal Easter Show.

Local AYFC Competitions are open to be run by local show societies and Agricultural Societies Council of NSW Next Generation representatives (ASC). Ideally, teams must win a YFC event held at a local ASC-recognised Show to be eligible to compete in the qualifying heats and State Final. Currently, any team nominated to the RAS of NSW by a local Show that wins a local show is eligible to enter qualifying heats, with places in the heats available on a first-come first-served basis.

### **Northern Territory AYFC Structure**

AYFC under development.

### **Queensland AYFC Structure**

The RNA Future Directions Committee and QLD Ag Shows Next Gen are progressing towards the below structure:

Local Competitions: present an exhibition event (non-competition). It is recommended by the Committees that local Shows use standardised branding issued by the Committee. Shows will manage the preparation and operation of their event, including challenges to suit local industry. Local Shows then nominate a team for the State Final to be hosted at the EKKA in Brisbane annually.

State Competition: heats and final to be hosted at the EKKA. The Committees will manage the preparation and operation of the event including marketing, sponsorship, insurance and prize money.

### Victoria AYFC Structure

AYFC under development.

### South Australia AYFC Structure

The SA Next Gen Group work with Adelaide Show organisers and SA Rural Services to run the Young Farmer Challenge State Final at Adelaide Show. All aspects of the Young Farmer Challenge will be held at the Adelaide Show.

The SA Next Gen Group will also aim to run the seven regional finals across the state each year in the seven different regions of South Australia. The shows who host the regional finals will change each year (if the local show Committee is capable of running the competition). Winning teams of the regional finals will qualify for the State Final at Adelaide Show.

Local Young Farmer Challenges will be run at local shows by local show Committees with support from the SA Next Gen Group. In general, if the SA Next Group attends a local Show to assist in starting up the competition, the SA Next Gen Group should not need to return to that show to assist in future years unless a regional final competition is taking place.

### **Western Australia AYFC Structure**

The recently formed RAS of WA Next Gen Group run the RASWA AYFC State Final at the Perth Royal Show each year. Affiliated shows submit their winning team who compete for the state championship title at the Perth Royal Show. The state winners will go on to compete at a national level. Local AYFC Competitions are run by the RAS of WA Next Gen group and local Affiliated Show Societies of WA. Teams should win a YFC event held at a local Affiliated Show to be eligible to compete in the State Final. Currently, any team nominated to the RAS of WA by a local Show that wins a local Show is eligible to enter the state final.

### **National AYFC Working Group**

The AYFC Working Group provides feedback and direction to the ASA National Next Gen on the AYFC program structure from local through to National level. The Working Group aid the development of resources for all levels of AYFC's, with a focus on sustainable participation, youth engagement, showcasing agricultural innovation and on-farm safety.

The AYFC Working Group members are a valuable resource for regional and local committees developing their AYFC competition.

### **AYFC Rules and Regulations**

### Interpretation

1. In these Regulations, unless there is something in the subject or context inconsistent there with:

ASA means Agricultural Shows Australia.

ASA Member means an agricultural show organisation who is a current ASA Core Member.

**Animal Welfare Policy** means the ASA Animal Welfare Policy.

Australian Young Farmer Challenge (AYFC) means the overarching young farmer challenge Competition series from local Competitions, through to a national Competition.

**Competition** means a contest between like Competitors, including heats and finals.

**Competitor** means an individual member of the competing Team.

**Final** means the last Competition, to decide the winner of the AYFC.

**Heat** means the Competition to decide which Teams are eligible to compete in the Final.

**Host State** means the State Show that is hosting the National AYFC.

**Australian Young Farmer Challenge Local** means the Competition hosted at a Local Show.

**Local Show** means any town or community based agricultural show, recognised by the State/Territory-based governing body and/or ASA Member.



Australian Young Farmer Challenge National means the highest level of AYFC Competition, consisting of teams representing each state or territory of Australia.

**Australian Young Farmer Challenge Regional** means the heats and final of the AYFC Regional Competitions.

Australian Young Farmer Challenge State means the heats and/or final of the AYFC State Competition, to be hosted by the State Show or an ASA Member Show or Society. The State YFC may be the final of a Regional YFC.

State Show means the agricultural show that is the highest level of competition in any given State or Territory (typically the capital city show), as recognised by the ASA (and is an ASA Member).

**Team** means the entrant into the Competition, consisting of 4 people. Teams must include both male and female Competitors. All female or all male teams are not eligible to compete.

**Working Group** means the ASA Next Gen National AYFC Working Group.

## AYFC Regulations — National Structure

### 4. National AYFC

- a. The National AYFC Competition will be hosted each year by a State Show.
- b. The opportunity to host the National AYFC Competition will be rotated between the State Show's.
- c. Each year the National AYFC Competition will be held in accordance with these AYFC Rules and Regulations and the AYFC special regulations of the Host State. Where there are discrepancies between the Host State's special regulations and the AYFC Rules and Regulations, the AYFC Rules and Regulations will prevail.
- d. No more than ONE (1) Team will be eligible to represent each state or territory of Australia.

### 5. State AYFC

- The State AYFC Competitions will be hosted annual by each State Show.
- The development and implementation of State AYFC rules and regulations are the responsibility of each individual State Show.
- c. State Shows should consider these AYFC Rules and Regulations when developing their State's regulations to ensure their representing State Team is eligible to compete at the National AYFC.

- d. The winning Team of the State AYFC is typically selected as the qualifying Team to represent the State or Territory.
- e. State Competition Compulsory Challenge Inclusions: Whilst the inclusion of certain machinery and agricultural sectors is not compulsory for a State competition, it is encouraged to ensure the calibre of competitors for the National Final is of a high standard.
- f. The State AYFC total cash prize money must not exceed \$500 per competitor.
- g. There is no limit to in-kind prizes (such as travel, product prizes and education bursaries).
- Attainment of insurances and competitor waivers for the State AYFC competitions is the responsibility of the individual competition organisers.

### 6. Regional and Local AYFC

- a. Regional and Local AYFC Competitions are hosted at the discretion of the State or Local Show committee.
- b. The development and implementation of Regional and Local AYFC rules and regulations are the responsibility of each individual Local or State Show.
- c. Local Shows should consider these AYFC Rules and Regulations and the rules and regulations of their State AYFC Competition when developing their AYFC rules and regulations, to ensure their representing team is eligible to compete at the State AYFC.
- d. The recognition of Regional and Local qualification Competitions for State AYFC Competitions are at the discretion of each individual State and Territory. Please contact your AYFC Working Group representative for more information about qualification competitions specific to each State and Territory.
- e. A Regional AYFC Heat or Final may be held at a Local Show as a culmination of local competitions from a group, district or community (E.G.: ASC of NSW Group 5 may host a Regional (i.e.: group) Heat and Final at a Local Show, to choose a representative Team for the State Final). Regional AYFC Competitions may be held at the State Show, prior to the State AYFC Competition.
- f. The Regional or Local AYFC total cash prize money must not exceed \$500 per competitor.
- g. There is no limit to in-kind prizes (such as travel, product prizes and education bursaries).
- Attainment of insurances and competitor waivers for State and Regional AYFC competitions is the responsibility of the individual competition organisers.
   Committees are advised to contact the State Working Group representative, and the Show insurance provider for further details.

### **AYFC Rules and Regulations continued**

# AYFC Regulations - National Competition Specifics

### 7. Eligible Teams:

To be eligible to compete in the National YFC, Teams must:

- Have submitted their application for entry (or via their State AYFC Coordinator) to the National AYFC Coordinator in the Host State within one (1) month of winning the State Final.
- b. Consist of four (4) Competitors.
- c. Have both male and female competitors. All female or all male teams are not eligible to enter.
- d. Have Competitors with minimum skills. One (1) member of each team is required to meet each of the following criteria for entry:
  - Hold a current drivers licence recognised by an Australian State or Territory.
  - ii) Be capable of hitching a trailer to a car and backing the trailer.
  - iii) Be competent at driving a tractor.
  - iv) Have experience in driving an all-terrain vehicle (ATV).
  - v) Be experienced in using a chainsaw.
  - vi) Be competent at handling livestock, including horses, sheep and cattle.
    - NOTE: Should a team have concerns that any of their members cannot meet the above criteria, they should refer their entry to their State representative.
- e. One reserve Competitor may be nominated by each team at the time of the State AYFC Competition. This reserve Competitor may act as a substitute for the National AYFC Competition in the event a Competitor is unable to attend the National AYFC competition. Substitutions must be review and accepted by the Working Group for the National AYFC Competition.

### 8. Eligible Competitors:

To be eligible to compete in the National YFC, Competitors must:

- Have Competitors aged between 18 and 35 years of age on the day the National AYFC takes place. Competitors may be required to provide proof of age.
- b. Have won their State AYFC Competition in the year preceding the National competition. If the winning team is unavailable to attend, the reserve placed team may compete in their place.

- c. Not have previously contested another State AYFC Final in the same Competition year.
- d. Competitors must reside in the State they are representing for the National YFC Competition or be within 50km of their State's border.
- e. Compete at their own risk.
- f. Undertake all Competition activities in a safe manner.
- g. Not be immediate family members or partners of:
- h. Competition Officials.
- i. Working Group members.
- j. ASA National Next Gen Committee members.
  - NOTE: If this situation arises, the competitor must declare this conflict of interest to the competition organisers which will then be taken to the National Steering Committee for discussion.
- k. Wear appropriate clothing to compete in the National AYFC Competition.

### 9. Compulsory National AYFC Challenges

- a. The National AYFC must include a theory-based section to test competitor knowledge. The type of theorybased challenge is at the discretion of the Host State.
- b. The National AYFC must include a minimum of 7 challenges run consecutively
- c. The National AYFC may include the following types of machinery:
  - i. Tractors
  - ii. Chainsaws
  - iii. Motorbikes or ATV's (two-wheel or four-wheel)
- d. The following agricultural sectors must be reflected in the challenges of a National AYFC Final:
  - i. An animal industry
  - ii. Grains or Horticulture Industry

### **10.Competition Prize Money**

- a. There is no limit to cash prize money for the National  $\ensuremath{\mathsf{AYFC}}$
- b. There is no limit to in-kind prizes (such as travel, product prizes and education bursaries).

### **AYFC Rules and Regulations continued**

# AYFC Regulations- Regional and Local Competition Specifics

### 11. Competition Guidelines

- a. The winning Team will be the Team that completes all the challenges correctly, in a safe manner and in the fastest time.
- Each Team will have a dedicated judge that watches each challenge of the Competition. The Judge will determine when the Team is permitted to move onto the next challenge. The Judge's decision is final.
- c. The Team will be permitted to progress when each challenge has been completed correctly and safely.
- d. The Team must complete every challenge safely and using the correct Personal Protective Equipment (PPE).
- e. Any errors made during each challenge will result in the Team having to re-do the challenge to complete it correctly, or receive a time penalty, based on the nature of the challenge.
- f. Teams can incur a time penalty for safety breaches.
- g. Teams may be disqualified in the event of a multiple safety breaches and/or dangerous activity affecting Competitors, Officials or spectators.

### 12. Risk, Release, Indemnity & Insurance

- The management of Risk, Release and Indemnity for participants in AYFC competitions is the responsibility of the Competition organisers.
- b. Competition organisers may produce a series of risk, health and safety documents. An example of the 'Competitor Waiver Form' used by the ASC of NSW has been provided as Appendix 9. Competition organisers are encouraged to use this document as a guide only and seek advice from their insurance providers and legal advisors as to the most suitable waiver form for their individual competition.
- c. Attainment of insurances for AYFC competitions is the responsibility of individual competition organisers. Competition organisers are encouraged seek advice from their insurance providers and own legal advisors for the coverage required for Competitors.

### 13. Animal Welfare

- a. If hosting an AYFC event, be aware of and adhere to the Australian Animal Welfare Standards and Guidelines, notably but not restricted to the Land Transportation of Livestock and Model Codes of Practice for the Welfare of Animals.
- In addition, National, State, Regional and Local AYFC competitions must adhere to the animal welfare policy of the Host Show.
- c. The RAS of NSW AYFC Animal Welfare Guidelines for use of live animals is included for your reference (appendix 5).

### 14. Risk Assessments

- a. It is essential for a risk assessment be carried out on each individual challenge included in AYFC. Control measures identified to minimise risks must be adopted.
- An example risk assessment template is included (appendix 8). Please contact your State representative to ensure the risk assessment procedure is followed in your State.



# **AYFC Competition Administration and Coordination**

### **AYFC Officials**

Several Officials are required to run an AYFC at all levels of Competition. The procedure for selecting Officials will vary at each Competition level however it is recommended to invite people outside of your potential Competitor base where possible. Consider the below Officials:

### **Judges**

A judge is responsible for timekeeping and monitoring each team's progress through the challenges. The judge will determine if each challenge was completed in accordance with the competition rules, including safety. Each team must be assigned a judge. Judges may adjudicate for ONE TEAM ONLY per competition. E.G.: 4 teams per competition heat requires 4 judges.

Judges must be provided with the list of challenges prior to the event and attend a full briefing (including safety briefing) prior to the competition.

### **Stewards**

A steward is responsible for a variety of tasks, including monitoring team progress (assisting judges), setting up of challenges and resetting equipment at the completion of each competition. Stewards must attend a full briefing (including safety briefing) prior to the competition.

### **Safety Stewards**

At least one Safety Steward must be nominated for each AYFC competition. The Safety Steward must be in attendance for the entirety of the competition and oversee all safety aspects of the competition.

### **Announcers**

Announcers plays a key role in audience engagement, participation and education.

When considering the AYFC announcer(s), consider an announcer:

- who knows the local show/community can be a great asset, especially if they understand the crowd and may have an existing rapport with officials and competitors.
- who understands the AYFC competition, challenges and safety aspects. Announcers with an understanding

of the AYFC will be knowledgeable enough to appreciate, and comment upon, the performances of the competitors and encourage all teams with equal enthusiasm. They will also enthusiastically engage the crowd and explain what is required in each challenge as teams progress.

- who understands the importance of sponsors to the success of the AYFC, including referring to the sponsors at every opportunity, with sincerity.
- with prior experience will assist with set up for the AYFC including AV checks, taking notes from officials, competitors and sponsors to refine their talking points and liaising with sponsors to allow Officials to focus on last minute preparations.

### **AYFC Safety Management**

The demonstration of on-farm safety and the safety of all Competitors is the cornerstone of the AYFC.

Each Competition much have a nominated Safety Steward and a comprehensive safety plan outlining each challenge in the competition. As noted in regulation 13.a., a risk assessment must be carried out on each individual challenge in the competition.

Safety briefings for each challenge must take place prior to each competition (i.e.: ALL TEAM must participate in a safety briefing prior to commencing a competition) and preferably by the nominated Safety Steward.

Competitors are expected to understand the safe use of machinery identified in section 8.c. prior to taking part in the competition.



### **AYFC Competition Administration and Coordination continued**

### **Safety - Competitor Clothing**

In adhere to safe work principles, all Competitors must wear a shirt with sleeves (short or long), long pants and closed toe shoes suitable for on-farm practical skills.

Personal Protective Equipment (PPE) must be supplied by the organising committee for each challenge and must be worn for all challenges where required. PPE must be included in the safety brief for Competitors and Officials, it is the responsibility of the safety steward to monitor the correct use of PPE for each challenge.

### **Safety - Breach Procedure**

In the event of a safety breach, the following rules apply:

- YELLOW FLAG: First Safety Breach 5 second hold up penalty applies
- **YELLOW FLAG:** Second Safety Breach 10 second hold up penalty applies
- ORANGE FLAG: Third Safety Breach Elimination
  of offending competitor from the remainder of the
  competition. The eliminated competitor must be the
  competitor who conducts the third safety breach.
- RED FLAG: Fourth Safety Breach Team Elimination

NOTE: A competitor or a team may receive an immediate ORANGE or RED flag (without the two YELLOW warning flags) for reckless or dangerous activity that may have affected Competitors, Officials or spectators.



### **AYFC Challenge Selection**

The key to your AYFC is the challenges! Set challenges that are:

### • Creative but practical.

- Challenges can be simple and do not require large machinery or animals if these are not available.
- Remember to include; education, new technology, safety, entertainment
- Ensure the challenges can be easily and quickly setup and packed up

### • Using local products and equipment.

- Use materials, equipment and livestock that are easily accessible and can be borrowed or donated.
- Specific to your local farming area.
- Testing of your young farmers and encouraging to next year's competitors.
  - Ensure the challenges are challenging if you want real farmers to compete there must be substance to the competition. This will ensure that the competition grows with integrity to become a wellrespected and established event.
  - Challenges are encouraged to test both physical skill and theoretical knowledge of agricultural and farming practices.

### • Entertaining to your audience.

- Small challenges that are hard to see are less engaging.
- Watch the timing of the event: 15-30 minutes is acceptable, remembering that you don't want to exhaust the farmers – or the audience

### **Appendix 5 – AYFC Animal Welfare Guidelines**

The ASA supports the Animal Welfare Guidelines as prepared by the Royal Agricultural Society of New South Wales for the NSW State AYFC Competition. It is recommended that each Show consults their veterinary committee or local veterinarian in the development of their challenges.

### **RAS of NSW Animal Welfare Guidelines**

A judge is responsible for timekeeping and monitoring eaThe Royal Agricultural Society of NSW recognises that animals are used for human purposes, such as food, fibre, companionship, recreation and research conducted for the benefit of both humans and animals. In designing and running agricultural competitions involving animals, it is the responsibility of the organisers, entrants, exhibitors and suppliers of animals to consider the welfare of animals in such use, which encompasses:

- Appropriate housing
- Management
- Nutrition
- Humane handling
- Veterinary treatment

### Housing

Provide your animals with adequate shelter when they are to remain in one position for more than 10-15 minutes within a challenge, as necessary, depending on the weather. This may mean providing shade or shelter from wind or rain. If conditions are mild, shelter may not be necessary. Animals should be provided with appropriate shelter when not directly involved in a challenge.

### **Nutrition**

Provide your animals with adequate food and fresh water when not directly involved in a challenge task. Dispose of waste feed appropriately.

Challenge design and animal handling

Challenges should not cause physical pain to animals.

Use appropriate animal handling techniques to reduce stress on your animals. Animals that are not trained to lead should be held in secure yards during challenges. For any challenge involving animal restraint, the use of halters is only appropriate for animals that are halter trained.

### **Transport**

Transport animals to and from the event site in a utility, trailer, van or truck with a fixed crate, or on a lead with the aid of a secure halter. If animals are to be moved within a challenge they are to be quietly drafted (for example sheep) or lead with the aid of a secure halter. Animals should not be picked up and carried, unless this is a part of normal husbandry practices for that species, for example poultry.

### **Animal selection**

Fit and healthy animals should only be selected for use in challenges.

Adult or mature animals should only be selected for use in challenges; however, gestating or geriatric animals should not be selected. This is to avoid unnecessary stress to immature animals that are not used to handling and husbandry procedures.

### **Veterinary supervision**

It is recommended that a Veterinarian is available to provide Veterinary treatment if required as a result of the use of animals in challenges.

The AYFC promotes high standards of animal care and the safety of people involved with animal handling. If you would like further information or advice regarding challenge design and the use of animals in AYFC competitions, please contact the Working Group members.
