Exemption from holding an Agricultural Show or all the usual sections in 2021

The Agricultural Societies Council of New South Wales Ltd will allow members an exemption up until 31 December 2021, if due to COVID-19, they do not conduct an annual agricultural show or conduct an annual agricultural show with less than the required five different types of sections (including a horse section and a pavilion of Arts and Crafts).

\$200 for COVID supplies

Shows are eligible for \$200 (+GST if the Show is GST registered) for COVID-19 supplies. Email invoice from the Show Society and receipts of the purchases to sarah.mcgregor@ascofnsw.org.au

I am pleased to announce that ASC of NSW will be hosting both the 2021 and 2022 National Young Judges, Paraders and Rural Ambassador Award at Sydney Royal in 2022. Unfortunately, the 2021 Ekka was unable to proceed due to Covid-19 and as such the decision has been made to have two National Finals Championships at the one location. Rescheduling the event will allow recognition of the skills and expertise that these Young Judges and Rural Ambassadors possess along with countless opportunities in terms of development and networking.

The ASC of NSW is working towards running their 2021 Dryland Field Wheat competition to celebrate this year's crop production but are monitoring closely the current restrictions and will make a final decision in the coming months.

She also works hard behind the scenes keeping the day to day accounting up to date and is willing to take on new tasks as they arise. ASC State Conference Wrap Up by Kim England

The ASC State Conference started with an address from Shane Fitzsimmons, Head of Resilience NSW. It was thanks to our good working relationship with the NSW government that enabled us to have Shane participate. The relationship with NSW government was further fostered through COVID-19 working groups and regular Crown Lands meetings. The NSW government supported Ag shows by providing Ag show specific factsheets/safety plans and financially through infrastructure funding.

Lyndsey Douglas took us on a tour of the various locations participating. It was exciting connecting across nine locations. Marla Calico, IAFE President and CEO spoke about growing stronger together. Engage with your fellow Show Societies or join the closed Facebook group for NSW Ag shows to ask questions and share knowledge. This will help Ag shows grow stronger together.

Speaking of volunteers, our panel session on recruiting and engaging volunteers shared some insights of how you can potentially sustain and grow your volunteer base. Think broadly and possibly engage people who live further afield. It is important to use your networks such as the show community to encourage all to have a sense of belonging, purpose, and connection to your local AgShow. Remember to let others help, and it is free to say thank you or show appreciation to recognize someone's help. Encourage others in, to become involved in their local show and ultimately grow the volunteer base. Congratulations to the ASC Award winners, finalist, and nominees! Thanks to those who took the time to nominate someone. It is very much appreciated.

Working with children and having child safety front of mind is important today and looking into the future. AgShows are community orientated and need to look after their community. Apply for your working with children check or if you already have it, share the details with your local show secretary to sustain our reputation as a family friendly, child safe environment.

Stacey Copas shared rituals for resilience to help you adapt when needed to face challenges and turn obstacles into opportunities. Wing it when things do not go exactly to plan – no one will know except the organizer!

It was great to hear about the success of Sydney Royal from the Vice President of the RAS John Bennett, and other shows that have been able to operate in 2021. The panellists' offered suggestions to help you plan and run your Ag shows later in the year. Share your progress with other shows or reach out to shows that have run for help. Maybe consider how to organize the pavilion to allow COVID safe movement through, you never know it may even allow more patrons to be able to access to view the hard work on display. Use online ticketing to sell tickets in advance, help with cashflow leading up to your show, guarantee people will attend because they already have a ticket, capture information of where they are from or what age bracket, they are in to learn and grow your attendance. Try cashless payments reducing the amount of cash held and improve safety and security.

The conference theme was Adapt, Sustain, and Grow. Think about how your show can adapt as things change, what you would like to sustain and how you could grow?

The ASC is taking up the challenge.

Adapt - Can you believe we held a hybrid conference like this? The feedback you provided will help us adapt and grow the next one. We are working remotely and from an office, we continue to be able to service members during lockdowns. **Sustain** – the ASC will continue to keep our members updated. We are here to support NSW Ag shows and provide guidance. **Grow** – we are looking at ways we can expand our support services to members, it may include webinars or a YouTube channel or a mentor program. We would love to grow the Showgirl and Rural Achiever programs. We are working towards increased young judges' education to encourage participation by young people to become tomorrow's judges.

Cancellations/Postponement of Horse Sections and additional Supplementary Events

If your Show Society cancels or changes the date of its show and/or holds a supplementary horse event, please contact the ASC office to ensure dates listings are correct and that RAS is aware of your competitors' qualification results.

Whiskers to Stay Put

The ASC is aware of the FEI ruling which came into place 1st July 2021 that prohibits the clipping/shaving of sensory hairs (horses' whiskers) which was passed as part of their veterinary regulations.

Many of our NSW Agricultural Shows run events within their horse programs which are either affiliated with Equestrian EA/Equestrian NSW or under their rules. The EA Board has voted to implement the recent FEI rule to ban the trimming of horse sensory hairs across all EA National Disciplines in the interests of horse welfare.

Vibrissae, or sensory hairs/whiskers, are the long stiff hairs growing on the chin, mouth and around the eyes and are used as organs of touch by the horse.

The FEI Veterinary Committee believes that the horse's sensory hairs (this does not include ears) must not be trimmed or removed as it reduces the horse's sensory ability...read more:

Showmens' Guild (Discretionary Mutual Fund Proposal)

Insurance developments relating to Ride / Amusement Operators and their current challenges in obtaining adequate insurance

The ASC is aware many members have recently received an e-mail from the Showmen's Guild, Subject: Insurance DMF, ASBFEO and your Showground. After consultation with both your insurance broker PSC Insurance Brokers and your insurers, we wanted to clarify a few points to assist Show Societies in responding to this e-mail.

The e-mail received directly from the Guild, was requesting you to ask your Showground owners if they would accept protection offered under a Discretionary Mutual Fund (DMF), as opposed to traditional insurance for Ride Operators, operating on their land. **Members may choose to assist the Guild with their request by forwarding this query to your Land Manager or refer to your Executive Committee/Board for a Show Society that own their showground.**

The ASC is awaiting response from Crown Lands from a state-wide perspective on the minimum insurance requirements as many showgrounds are on Crown Land.

Members who own their showground can advise the Guild that they are currently waiting on ASC's advice prior to providing a response to the Guild's query.

Background:

Ride Operators / Guild are currently having difficulty in obtaining traditional insurance in the marketplace and are considering establishing their own Discretionary Mutual Fund (DMF) as an alternative risk transfer solution. DMF claims are paid solely at the "discretion" of the mutual. If there are insufficient funds, claims are not paid.

ASC is liaising with the Guild and are keen to understand

- how the DMF will be sufficiently funded to ensure it can meet its future claims obligations;
- what certificate of protection will be provided;
- who the reinsurer will be and at what limit will reinsurance cover a claim (reinsurance is a usual feature of a DMF for large claims or 1 in ten-year events)?

ASC's insurance programme continues to provide the necessary cover for agricultural shows to operate their events. The ASC public liability insurance has a \$50M limit. Currently, the minimum insurance cover required is \$20M for public liability for suppliers/trade space/ride operators (any business operating at your event). Any deviation from this amount requires insurer approval.

Showmen's Guild (Discretionary Mutual Fund Proposal) continued

Apart from checking third party insurance certificates, members are also advised to maintain robust risk management practises such as:

- Checking a current engineer's report signing off the ride as safe. The serial number on the report should be cross referenced against the serial number on the ride equipment;
- Evidence of the ride operator's safety checks;
- Checking the ride operator's incident history.

Amusement rides and sideshow alleys are defined as a Category B activity under your Liability insurance programme, meaning the Show Society is covered for indirect negligence, subject to the activity being run by a third-party providing proof of **Insurance**.

Has your Show Society taken advantage of recognising the significant contribution that someone has made to your Show Society by applying for a RAS of NSW Agricultural Shows Award?

The RAS of NSW Agricultural Shows Award medal is available to each Show Society within NSW. The RAS of NSW will review and approve all applications and cover all the costs associated with producing and posting out the medals to every NSW Show Society that nominates a worthy recipient for this award. The RAS of NSW values and recognises the contribution regional Agricultural Shows have made, not only to Australian Agriculture but also to their local communities and this is another way for us to celebrate these contributions.

Shows will be required to apply for the medal each year and applications must be received no less than 12 weeks prior to presentation date. Legend of Binnaway Show - Harry Powell

Harry started volunteering for the Show in the late 1970's. One of his first jobs, that lasted for about 20 years was to take a truck to Mendooran Showground to pick up the show jumps that were borrowed every year for the Binnaway Show. He was Ring Master for a few years, then President from 1981-1984 before going back to volunteering and becoming President again in 2012, a position that he still holds.

Neighbour and generous donor to the Binnaway Showground, Steve Bond is responsible for Harry's initial involvement with the Show. The horse section is a favourite tradition at the Show.

Harry is very proud of the incredible support that he receives from the committee, volunteers, local businesses, and the community.

The 2021 Binnaway Show was the most memorable with a record crowd of 1100 and record entries in many sections. A wardrobe moment for someone close to Harry at the popular Art Show evening was a moment he will not forget.

The interest shown and the value of the Young Judges Day which is run as part of the Show week is noteworthy. It is good to see so many young students who are our next generation of leaders and workers enthusiastic and engaged while learning about the great diversity of the agricultural industry.

Local Show Legends



Legend of Dubbo Show – Pauline McAllister

Pauline's first involvement was with Deniliquin Pastoral and Agricultural Show Society.

In 1962, when, as the then fiancé of her late husband Trevor McAllister she was asked by his father Donald if she would be a penciller for him in the show jumping ring. It was whilst doing this that she fell in love with the show movement. Donald McAllister, who was a past President of the Show Society had introduced show jumping to the Deniliquin Show in 1960. It was at the Deniliquin Show, always held on the first weekend in March each year that the big-name showjumpers honed their skills on the way to the Sydney Royal.

In 1975, married with four young children her husband Trevor became President of the Deniliquin Show. In those days there were no women on the show committee but there was a Ladies committee of which the President's wife was expected to be President. From the late 60's, Pauline was Chief Steward of the Showgirl section of the Show and thus began her long association with the Showgirl movement.

In 1988, Trevor and Pauline moved to Dubbo, where they purchased a marquee and party hire business. A few weeks after taking over the business, a member of the Dubbo Show Society committee approached them explaining that the previous owners of the business were sponsors of a major jumping event at Dubbo Show and they were wondering if we would be interested in continuing the sponsorship. With enthusiasm Pauline let her know that they were show people from way back and would love to continue with the sponsorship. Pauline joined the committee and was Chief Steward of the Showgirl section for many years.

Pauline's husband was elevated to the position of President in 1995, which he held until 2000. So, once again Pauline found herself in the roll of President's wife. Alongside her husband, Pauline hosted the official luncheon on the Saturday of the Show and was instrumental in introducing the Sunday night dinner after the Show.

The most memorable show was probably 'the wet show'. It was 1996, the second year of Trevor's Presidency. Pauline remembers that the rain did not stop. 1996 was the only year the Dubbo Show Society ever claimed on their rain insurance.

One of the proudest moments came in 2012 when alongside Trevor, they were both awarded honorary life membership of the Dubbo Show Society. After Trevor's passing in 2020, Pauline was invited to take his position as one of three patrons of the Show Society. What an honour, and to learn that she was to be the first female patron in the 148-year history of the Dubbo show society was very humbling indeed.



Legend of French's Forest Show – Wendy Taplin

Wendy was a regular competitor at gymkhanas and shows when young. After marrying and having a family, Wendy never lost interest in horses and shows. After being on the committee, Wendy graduated when she was elected to be President in 1999 and leads a small but dedicated committee to run not only the Annual Show but a Spring Horse Show as well.

Wendy runs the Pavilion classes at the show, assists in the office, taking waivers and selling ring tickets and organises and prepares all the food with the assistance of her good friend, Julie Ballard.

Wendy has been working closely with Northern Beaches Council since they decided to expand the children's playground.

Not only is Wendy a show legend, but she should also be termed "Showground Guardian" – she lives locally so when there is a problem at the showground she is contacted. After bad storms and trees or large branches have come down, Wendy contacts Northern Beaches Council to inform them to come and clean up. In the bushfires earlier this year, the Showground was opened as a horse evacuation centre – Council came and put-up temporary yards for the horses but forgot to open the toilets for the horse owners. Who was called – Wendy who then sorted out the problem!


