1. The electronic funds transfer will be made to the BSB or Swift Code, account number and account name, as indicated in this Application for Entry.
2. The information provided in the Bank Details section for this Application for Entry is very important. You understand that you must communicate any change in the information to the RAS. 3. The RAS shall not be liable for any loss, which may arise solely by reason of error, mistake or fraud regarding this information.
4. With respect to the EFT process, RAS shall be responsible up to the point when the financial institution receives or has control of the transaction. Any loss of the data at or after that point will be borne by the Exhibitor unless the loss is due solely to negligence of RAS or its originating bank.
5. With respect to the payment of refunds, prize money, and sales proceeds, the RAS will no longer be paying by cheque. All monies will be provided via EFT to the nominated bank account (the Payee).

DELIVERY OF FLEECE

The Fleece must be delivered to the Sydney Showground, Sydney Olympic Park, by 4.30pm on **Wednesday 8 March 2023**. Each fleece must be enclosed separately in one of the plastic bags provided, with the appropriate label attached. Polypropylene should not be used to tie up the fleece bags.

DISPOSAL OF FLEECE

The RAS will repack and re-address Exhibits and deliver them to a nominated Wool Broker in Sydney if so instructed. No responsibility will be accepted for loss or damage in transit.
